During the twelve months ended March 31, 2024, continued momentum in M&A, as well as a resilient Equity Capital Markets operation, drove our US investment banking team's significant level of activity and client engagement:

- Completed 96 total transactions for 86 different corporate clients
- Announced 58 advisory engagements, which ranged from minority raises, strategic sales, and private equity recaps to corporate divestitures and take-private transactions
 - Nearly two-thirds of M&A transactions involved financial sponsors on at least one side of the deal
- Nearly 100 M&A assignments either active and currently in market or engaged and launching in the near term
- Added four senior bankers across practice areas in the US, including Healthcare Services, Human Capital Management, and Industrial and Infrastructure Services
